SPECIAL CONVOCATION - 2018 FOR CONFERRING DEGREES IN ABSENTIA

Students of different faculties under Yenepoya deemed to be University who have fulfilled the requirement to receive their UG/PG Degrees, Diplomas, Fellowship certificates are hereby informed that there will be a special convocation for conferring Degree **in absentia** to be held on **31st March 2018**. Such of those students who are desirous of receiving certificate **in absentia** are requested to send their consent through the mail yuconv@yenepoya.edu.in to Controller of Examinations before **08th March 2018**. Those who have not applied for convocation at the time of completion of course and also of those who are completing the course on or before **20th March 2018** need to apply before **08th March 2018** if they desire to receive certificate in Absentia and send their consent.

The consent sent through the yuconv@yenepoya.edu.in mail is only accepted. No other means of communication is entertained and consent sent after **08th March 2018** is **not considered for this Convocation**.

On scrutiny of their consent and applications, if they are found satisfactory in all respects, they will be conferred with Degrees/ Diplomas/Fellowships/Certificates as the case may be in absentia on **31st March 2018**.

The certificate can be collected any time after **31st March 2018** either in person from the office of the Controller of Examinations or can be sent by registered post to those who request for it through mail yuconv@yenepoya.edu.in

PLEASE NOTE: The students whose degree is conferred **in Absentia** on **31st March 2018** cannot participate in the **REGULAR CONVOCATION** which is scheduled to be held in the month of **September 2018**. Hence those who want to participate in regular convocation need not apply /send the consent to receive the degree certificate in this special convocation **in Absentia**.

Important information: CONVOCATION IN ABSENTIA IS THE DEGREE CONFERRED IN THE ABSENCE OF THE STUDENTS.

THE CERTIFICATES WILL NOT BE ISSUED TO THE STUDENTS ON THAT OCCASION.

THE STUDENTS CAN COLLECT THE DEGREE CERTIFICATE ONLY ON LATER DATES FROM THE UNIVERSITY EITHER IN PERSON OR THROUGH POST.

THE STUDENT WHOSE DEGREE IS CONFERRED IN THIS CONVOCATION CANNOT PARTICIPATE IN ANY NEXT CONVOCATION.
