Subject: Request for reconsideration of response value on metric 3.3.3

This is to bring to your kind notice that the SSR submitted by Yenepoya (Deemed to be University) has been prequalified for accreditation process. We have received an intimation in this regard vide email dated 31st May 2022 from NAAC alongwith instructions to be complied for initiating the accreditation process. One of the instructions is to upload the validated SSR on the website of the University.

As we were preparing for hosting the SSR on our website, a scrutiny of the SSR contents was performed and noticed a paradoxical situation with regard to metric no. 3.3.3.

During the process of DVV there was a query on metric 3.3.3.1 "Number of awards/ recognitions received by the Institution/teachers/research scholars/students year-wise during the last five years" was raised and we were given option to rework on the data. Accordingly, the exercise was carried out and a modified data was submitted.

Nevertheless, the revised data were also not considered by DVV but retained the original suggested input and final recommended input reflecting as zero awards and recognition for innovations for all the five years covered under assessment period.

In this regard, we wish to state that unlike in technical education/research field there is hardly any dedicated forum for presenting the innovations in Health and Allied fields of research. Therefore, the innovative findings as part of research outcomes generally are presented in the relevant conferences. NAAC has excluded patenting from innovation but an alternative body to recognize the innovation in research has not been suggested. Therefore, it was difficult for the University to decide on the awards/recognition.

Hence, we considered those certificates of merit which were awarded special credits by the

Scientific Boards for unique findings and having innovation potential or prospect.

Further, Yenepoya (Deemed to be University) has been ranked as one among the top institutions with BAND Excellent by Atal Ranking of Institutions on Innovation Achievements (ARIIA) ranking, MHRD/Ministry of Education, Government of India in the year 2021 and under BAND A in the year 2020. This exercise ranking must have definitely taken into consideration the innovation outputs of this institution. This being the scenario for innovation ranking, NAAC/ DVV has awarded zero input for innovation despite providing certificates as evidence. Though this metric falls under quantitative the ambiguity on deciding awards/ recognition for innovation brings in subjectivity. Therefore, we as per the advice of DVV team reexamined the certificates and those findings fitting into innovation potential were identified and resubmitted for the kind consideration of NAAC during DVV clarification. Accordingly, we feel it is appropriate once again to appeal NAAC for reconsideration of the input in the light of the merits of this University for innovation.
