



1. Purpose

The purpose of this SOPs to describe in detail the method of exemption from ethics review of a research protocol submitted to the YEC 2 for ethical clearance.

2. Scope:

The SOP applies to the initial review of all research protocols submitted to the YEC 2 for ethical clearance

- Categorized by the Member Secretary under "exemption from review" as per the ICMR Ethical guidelines for research on human participants and fulfils the criteria for "exemption from review "as per SOP 07/v2 version
- Where the PI has requested for exemption from ethics review

3. Responsibility:

• The Chairperson will:

Approve the letter of communication to the principal investigator stating that the protocol is exempted from ethical review

The Member Secretary

The Member Secretary will do an initial screening of the protocol

The Member Secretary will categorise the protocols into "exemption from review" as per the ICMR ethical guidelines for research on human participants based on the initial screening and in consultation with the Chairperson.


The Member Secretary will record the reasons for include the protocol under the category of "exemption from review".

The secretariat will list the protocol in the "exemption from review" category in the agenda of the next YEC 2 meeting.

The Secretariat will:

It is the responsibility of the secretariat for recording and filing of the decision of the Member Secretary and the chairperson to include the protocol under the category of "exemption from review" including the reasons stated.

List the protocol in the "exemption from review" category in the agenda of the next YEC2 meeting for ratification

4. Detailed instructions:

Receiving the submission of protocol

Once the secretariat receives the complete protocol submission from the PI , the secretariat will check for the completion of protocol

The secretariat will also file any request for exemption from review from the PI

4.1.3. The Secretariat will forward the application and the protocol to the Member-Secretary within 2 days

Categorization of protocol into 'exemption from review':

The Member Secretary will consider the protocol for exemption from review based on the criteria laid down in the ICMR ethical guidelines for research on human participants, when the protocol involves less than minimal risk

After the protocols are classified under the category of "exemption from review" by the Member-Secretary in consultation with the chairperson, the secretariat records the decision in the file along with the reasons

Exemption process:

The member secretary will read the protocol for risk assessment


The Member Secretary in consultation with the chairperson goes through the project

summary and the exemption request.

If the protocol and related documents satisfy the criteria stated in the ICMR ethicalguidelines for research on human participants and fulfil the criteria for inclusion in the "exemption from review category as described in YEC2/SOP 7, the Member Secretary in consultation with the Chairperson, takes a decision.

The Member Secretary records the decision on the Exemption Form (form reference)

4.3.5 The exemption approval is signed by the Chairperson/ Member Secretary with date.
